## **Tystiolaeth**

Wrth bennu gradd, gellir defnyddio'r mathau canlynol o dystiolaeth ym mhob cymhwyster:

### **Cyn-bapurau wedi eu haddasu**

Bydd yr ysgol yn defnyddio hen bapurau â addaswyd gan CBAC wrth osod tasgau i helpu i bennu gradd ar gyfer pob cymhwyster. Mae cyn-bapurau wedi'u haddasu eisoes wedi cael bod trwy broses sicrhau ansawdd allanol; yn cael eu cefnogi'n llawn gan gynlluniau marcio; yn gyfarwydd i ddysgwyr a staff. Bydd athrawon yn sicrhau bod y cyn-bapur hyn yn cael ei ymgorffori fel rhan o'r broses addysgu a dysgu arferol yn lle gweithgareddau eraill a gyflawnir yn y gwersi.

### **Asesiad di arholiad**

Mae ADA yn bodoli mewn llawer o gymwysterau. Bydd athrawon yn defnyddio perfformiad dysgwyr yn yr elfen hon i helpu i gyfrannu at bennu gradd. Fodd bynnag, bydd athrawon yn ystyried pwysiad yr elfen hon i sicrhau bod y radd a ddyfernir yn adlewyrchu'r safon gyffredinol yn gywir.

### **Tystiolaeth arall**

- a) Gall athrawon ddefnyddio tystiolaeth o gyn-bapurau CBAC a gwblhawyd yn flaenorol sydd wedi bod trwy broses sicrhau ansawdd allanol a'u cyhoeddi gyda chynllun marcio wedi ei gymeradwy ac wedi'u cwblhau o dan amodau a reolir yn briodol.
- b) Asesiadau a gynhaliwyd cyn cyhoeddi'r dull yma gan CBAC o weithredu e.e ffug arholiadau. Gellir defnyddio'r math yma o dystiolaeth i gadarnhau dyfarniad ond nid o reidrwydd i benderfynu ar ddyfarniad. Y rheswm am hyn yw na fyddai dysgwyr, ar adeg ei gwblhau, wedi bod yn ymwybodol y byddai angen y darn hwn o waith i bennu eu gradd. Mae hyn wedi'i gynllunio i sicrhau tegwch a chwarae teg i bob dysgwr.

Bydd nifer y darnau o dystiolaeth sy'n ofynnol i bennu gradd yn amrywio fesul cymhwyster. Bydd athrawon yn sicrhau bod digon o gyfle i ddysgwyr ddarparu tystiolaeth glir i ddangos cymhwysedd yn erbyn prif hanfodion asesu allweddol y cymhwyster dan sylw; mae themâu allweddol o'r fath wedi'u dogfennu yn fframweithiau pwnc CBAC.

Ni fydd y dystiolaeth a gynhyrchir yn cael ei gasglu neu eu gwblhau ar ffurf arholiad h.y mewn neuadd dan amodau arholiad ac hyd amser arholiadau arferol.

## **Evidence**

In determining a grade, the following types of evidence can be used in each qualification:

### **Adapted past paper questions.**

The school will make use of WJEC adapted past papers when setting tasks to help determine a grade for each qualification. Adapted past papers have already been externally quality assured; are fully supported by mark schemes; are familiar to both learners and staff. Teachers will ensure that these past papers are incorporated into normal teaching and learning in replacement of other activities undertaken on lessons.

### **Non-examination Assessment**

NEA exists in many qualifications. Teachers will use the performance of learners in this element to help contribute towards the determination of a grade. However, teachers will consider the weighting of this element to ensure that the grade awarded accurately reflects the overall standard.

### **Other contributing evidence**

- a) Teachers may use evidence from previously completed WJEC past papers which have been externally quality assured and published with an approved mark scheme and completed under appropriately controlled conditions.
- b) Assessments undertaken prior to the publication of the agreed WJEC approach e.g mock examinations. This type of evidence may be used to confirm a judgement but not necessarily to determine a judgement. The reason for this is that at the time of completion, learners would not have been aware that this piece of work would be required for determining their grade. This is designed to ensure fairness and equity for all learners.

The number of pieces of evidence required to determine a grade will vary per qualification. Teachers will ensure that there is sufficient opportunity for learners to provide clear evidence to demonstrate competency against the key theses of a qualification; such key themes are documented in the WJEC subject frameworks.

The evidence generated will not be completed in the form of an examination i.e. in the Hall with external invigilators.
