POLISI CODI TÂL

Yn unol â deddfwriaeth mae Corff Llywodraethol wedi mabwysiadu polisi i godi tâl ar ddisgyblion am:

- rhai gweithgaredd ac ymweliadau tramor/preswyl/anarferol y tu allan i oriau'r ysgol, oni bai eu bod yn angenrheidiol at bwrpas arholiad allanol, y Cwricwlwm Cenedlaethol, neu ofynion statudol. Bydd yr ysgol yn cynnwys tâl gweinyddu, i brosesu taliadau o'r fath.
- arholiadau allanol pan fod dysgwyr yn methu â chyflawni'r gofynion neu fynychu'r arholiad heb reswm digonol.
- deunydd crai ar gyfer pynciau megis Technoleg, Celf ac Arlwyo, lle mae'r rhieni wedi nodi dymuniad i gadw'r deunydd gorffenedig.
- difrod bwriadol i eiddo'r ysgol neu am golli eiddo'r ysgol.
- gwersi offerynnol a ddarperir gan wasanaeth cerdd.
- gostau llety a bwyd ar ymweliadau addysgol.

Cyfraniadau gwirfoddol.

Trefnir ymweliadau a gweithgareddau allgyrsiol addysgol yn achlysurol ac ymgwymerir â hwy yn ystod oriau arferol ysgol. Maent yn rhan anhepgorol o gwricwlwm ysgol a disgwylir i bob disgybl ymgymryd â hwynt, fodd bynnag ni ellir eu cynnal o fewn cyllideb yr ysgol. Gwahoddir cyfraniad ariannol gan rieni tuag at gostau rhai o'r teithiau a digwyddiadau yma, ond sicrheir na waherddir disgyblion rhag cymryd rhan pan na all eu rhieni gyfrannu. Gellir gwneud cais am gyfraniad ariannol tuag at rhai gweithgareddau trwy gynllun yr Awdurdod Addysg Leol. Fodd bynnag mae'n bosibl na fydd modd cynnal rhai gweithgareddau heb gefnogaeth wirfoddol deilwng.

CHARGING POLICY

In accordance with legislation the Governing Body has adopted a policy to charge pupils for:

- overseas/residential/unusual out-of-school visits, unless they are necessary for the purposes of an external examination, the National Curriculum, or statutory requirements. The school will apply an administration charge, to process such payments.
- some extracurricular activities. The school will consider the inclusion of an administration charge, to process such payments.
- raw material for subjects such as Technology, Art and Catering, where parents have indicated a wish to keep the finished material.
- external examinations where the learner has failed to achieve the requirements or has not attended the examination and given an adequate reason.
- deliberate damage to school property or for the loss of school property.
- instrumental lessons arranged by a music service.
- the cost of accommodation and food during educational visits.

Voluntary contributions

Extra-curricular activities and educational visits are arranged periodically and they are undertaken during normal school hours. They are an indispensable part of school curriculum and all pupils are expected to engage in them, however they cannot be held within the school budget. Parents are invited to make a financial contribution towards the costs of some of these trips and events but the school will ensure that pupils will not be excluded if their parents are unable to make a contribution. Parents can apply for financial assistance for some extracurricular activities through the LEA. However it is possible that the school will not be able to go ahead with some activities without sufficient voluntary contributions.
